

## StepsWeb 'StepsGuy Makes a Movie' Competition 2025 Terms & Conditions

This competition is being run by The Learning Staircase Ltd (T/A StepsWeb) to increase student engagement in the StepsWeb program and as a fun end of school year activity. It is organised and conducted entirely by The Learning Staircase Ltd with no involvement by any third party. Information given by entrants to the competition will be used solely for the purposes of the competition.

- 1. By entering this competition, you are agreeing to abide by these Terms and Conditions.
- 2. The competition is open to students on school, tutoring, or home accounts and any students who attend a school with a StepsWeb licence.
- 3. Entries are to be made by teachers, parents/guardians or tutors on behalf of their students.
- 4. There is no limit to the number of entries made by any student.
- 5. There is no entry fee.
- The winning entry will be used on the top of the StepsWeb website from December 2025 to mid-January 2026. It will also be announced on a StepsWeb newsletter and on StepsWeb social media pages.
- 7. By entering the competition, you grant The Learning Staircase Ltd permission to use, reproduce, adapt, and share the artwork entered for promotional, educational, and marketing purposes, including on social media, the website, and in print materials. Ownership of the original artwork remains with the entrant.
- 8. The closing date for the competition is 26 November 2025. Any entries received after that date will not be considered.
- 9. Judging will take place in the week starting 1 December 2025 with the winning entry announced by 5 December 2025.
- 10. Judging will be undertaken by the staff of The Learning Staircase Ltd. Their decision is final, and no correspondence concerning their decision will be entered into.
- 11. The teachers, parents/guardians or tutors who submitted the winning entry will be notified by The Learning Staircase and the entrant will then be sent the prize from their age category. The prize is as stated on the competition web page. No cash, or other alternatives will be offered. The prize is not transferrable.
- 12. Sufficient information about the entrant will be required to identify the entrant for the purposes of giving the prize. This is likely to be no more than the entrant's first/given name, age, and school.
- 13. Submitting your artworks automatically permits The Learning Staircase Ltd to post online and share the artworks with the entrant's first name, age, and school name on social channels. Including the artworks of those that are not the winning submissions.
- 14. By submitting an entry, you grant The Learning Staircase Ltd a perpetual, royalty-free license to adapt, modify, reproduce, and use any designs included in the artwork for the purpose of creating content within StepsWeb products. The Learning Staircase Ltd may also credit the artist on social media channels if their design is selected for adaptation.
- 15. Entries can be posted or scanned and sent electronically, providing that they are of sufficient quality to be exhibited on a website.
